- i) Post graduate degree in Mathematics with minimum 55% marks.
- ii) M.Ed. degree with minimum 55% marks;

iii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility

Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil. /Ph.D.Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SET.

OR

- i) Post graduate degree in Mathematics with minimum 55% marks.
- ii) Post gratuated (M.A.) elegree in Education with minimum 55% marks.
- iii) B.Ed./B.El.Ed. degree with minimum 55% marks.
- iv) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SET or who are or have been awarded a Ph.D. Degree in accordance with the

University Grants Commission (Minimum Standards and Procedure for Award of M.Phil. /Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SET.

- The fulfillment of these conditions is to be certificate by the Registrar or the Dean (Academicaffairs) of the University concerned.
- 2) NET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SET is not conducted. However, Ph.D. degree shall remain the minimum eligiblity for appointment of Assistant Professor in such disciplines.

The Ph.D. degree has been obtained from a foreign university with a ranking among top 500 in the World University Ranking (at any time) by any one of the following:

- A relaxtion of 5% shall be provied, (from 55% to 50% of the marks) to the Ph.D. Degreeholder who have obtained their Master's Degree prior to 19th September 1991.
- A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by a recognized university, at the Master's level shall also be considered valid.
- A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/ Scheduled Tribe/Other Backward Class (OBC)(Non-Creamy Layer)/Differently-abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disablitiy including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e)Multiple disbalities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading sysytem is followed) and the relaxation of 5% to the categories mentioned above are permissible, based anly on the qualifying marks without including any grace mark procedure.

- 2. The original certificates must be produced at the time of interview.
